

BYLAW NO. 02/10

BEING A BYLAW OF FLAGSTAFF COUNTY, PROVINCE OF ALBERTA, FOR THE PURPOSE OF AUTHORIZING SEVERAL RATES OF TAXATION, INCLUDING GRANTS IN LIEU, IMPOSED ON THE TAXABLE ASSESSMENT FOR ALL PURPOSES FOR THE YEAR 2010.

WHEREAS

the total requirements of Flagstaff County, as shown in the Estimate of Revenue and Expenditure for the year 2010 are as follows:

AND WHEREAS

the total assessment of land, buildings and improvements for Alberta School Foundation Fund purposes within the County, are as follows:

AND WHEREAS

the total assessment of land, buildings and improvements for the East Central Alberta Catholic Separate Schools is:

Residential & Farmland	11,135,868
Non-Residential and Linear	9,279,530

AND WHEREAS

for all other purposes the total assessment of all assessed property within the County is:
1,231,208,850

AND WHEREAS

the Estimated Revenue other than from Taxation is estimated to be:
2,733,281

AND WHEREAS

the rates hereinafter set out are deemed necessary to provide the amounts required for Municipal, School, Flagstaff Regional Housing Group, Flagstaff Waste Management and Recreation purposes;

AND WHEREAS

the assessor has assigned the assessment classes to the property on Flagstaff County Assessment Roll as Class 1 - Residential, Class 2 - Non-Residential, Class 3 - Farm Land and Class 4 - Machinery and Equipment;

NOW THEREFORE

by virtue of the powers vested in it under the *Municipal Government Act*, being Chapter M-26.1, 1994, the Council of Flagstaff County, enacts as follows:

THAT

the Chief Administrative Officer be and is hereby authorized and required to levy the following rates of taxation on the assessed value of all Class 1 Residential assessable property as shown on the Assessment and Tax Roll:

AND THAT

the Chief Administrative Officer be and is hereby authorized and required to levy the following rate of taxation on the assessed value of all Class 2 Non-Residential assessable property as shown on the Assessment and Tax Roll:

Flagstaff Regional Housing Group	0.2024 mills
Alberta School Foundation Fund	4.0478 mills
East Central Alberta Catholic Separate Schools	4.0478 mills
Flagstaff Waste Management	0.1480 mills
Uniform Recreation	0.3049 mills

AND THAT

the Chief Administrative Officer be and is hereby authorized and required to levy the following rate of taxation on the assessed value of all Class 3 Farm Land assessable property as shown on the Assessment and Tax Roll:

the Chief Administrative Officer be and is hereby authorized and required to levy the following rate of taxation on the assessed value of all Linear assessed property as shown on the Assessment and Tax Roll:

Alberta School Foundation	4.0478 mills
East Central Alberta Catholic Separate Schools	4.0478 mills
Flagstaff Waste Management	0.1480 mills
Uniform Recreation	0.3049 mills

AND THAT

the Chief Administrative Officer be and is hereby authorized and required to levy the following rate of taxation on the assessed value of all Class 4 Machinery and Equipment assessed property as shown on the Assessment and Tax Roll:

Municipal purposes	13.2199 mills
Flagstaff Regional Housing Group	0.2024 mills
Flagstaff Waste Management	0.1480 mills
Uniform Recreation	0.3049 mills
