Defining Maximum Allowable Weights Permitted on Certain Municipal Roads

Pursuant to the authority granted by the Minister of Infrastructure under the Traffic Safety Act and Bylaw 09/17; **Flagstaff County orders that effective 0700 hrs, Wednesday, April 3, 2019;** permitted weights for roads located within Flagstaff County are as follows:

Location	Restriction
<b>A.) The following Oil Surface Roads in the County are banned at 50%</b>	
1) Range Road 151, north of Hwy #13 for 0.4 mile	50%
2) Range Road 95A, west of Range Road 100 for 1.0 mile	50%
3) Range Road 100A, north of Hwy #13 for 0.35 mile	50%
4) Range Road 103, north from SH: 608 for 7.0 miles	50%
5) Town of Hardisty to Range Road 101 for 0.8125 mile	50%
6) Township Road 442, east of Range Road 130 for 2.1 miles	50%
7) Township Road 442, east of SH: 869 for 0.4375 mile	50%
<b>B.) All Graveled/Dirt/Sand Roads in the County are banned at 75%</b>	
<b>With the exception of the following roads:</b>	
1) Arterial Roads	100%
2) Range Road 122, north from Hwy #13 for 7.0 miles	100%
3) Township Road 420, east of SH: 872 for 4.5 miles	100%
4) Township Road 452, east of SH: 855 for 4.0 miles	100%
5) Range Road 132, north of SH: 602 for 4.0 miles	100%
6) Range Road 125, north of SH: 608 for 6.0 miles	100%
7) Range Road 123, south of SH: 602 for 7.5 miles	100%
8) Range Road 164, north of Hwy #13 for 900 meters	100%
9) Township Road 440, east of Hwy #13 for 1.7 miles	100%
10) Township Road 433, east of SH: 881 for 1.2 miles	100%
11) Range Road 100A, north of Township Road 420 for 1.0 mile	100%
All secondary Highways in the County are under Provincial jurisdiction:	See Below
