BYLAW NO. 04/21

BYLAW 04/21 IS A BYLAW OF FLAGSTAFF COUNTY IN THE PROVINCE OF ALBERTA. TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN FLAGSTAFF COUNTY FOR THE 2021 TAXATION YEAR.

WHEREAS

Flagstaff County has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held April 28, 2021; and

WHEREAS

the estimated municipal expenditures and transfers set out in the 2021 budget for Flagstaff County total \$30,703,075: and

WHEREAS

the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$8,746,875 and the balance of \$20,955,550 to be raised by general municipal taxation; and

WHEREAS

the requisitions are:

WHEREAS

the Council of the Municipality is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and requisitions; and

the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta 2000 and;

WHEREAS

the assessed value of all property in Flagstaff County as shown on the assessment roll is:
