BYLAW NO. 03/14

BEING A BYLAW OF FLAGSTAFF COUNTY, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF PRESCRIBING DIFFERENT MAXIMUM SPEEDS FOR ALL OR ANY PART OF ANY HIGHWAY DESIGNATED IN THIS BYLAW.

Under the authority and pursuant to the provisions of Section 13 of the *Traffic Safety Act*, being Chapter T-6, R.S.A. 2000 and amendments thereto the Council of Flagstaff County enacts as follows:

- **THAT** 1. This Bylaw may be cited as the Speed Limits Bylaw.
- **THAT** 2. The maximum speed limit on that portion of Range Road 095 beginning North from Highway 13 and continuing North for an approximate distance of 1,400 meters, shall be 35 kilometers per hour (km/hr).
- THAT

 3. The maximum speed limit on that portion of gravel road which runs North from Highway 13 to the Flagstaff Regional Solid Waste Management Association located at SW 11-45-12-W4, shall be 60 km/hr.
- 4. The maximum speed limit on Range Road 102 North of Highway 13 for 200 meters to Township Road 430A, shall be 50 km/hr. The maximum speed limit on Township Road 430A from Range Road 102 to the corporate limits of the Town of Hardisty, shall be 60 km/hr.
- THAT 5. The maximum speed limit on that portion of road adjacent to the corporate limits of the Town of Sedgewick, commencing at Range Road 124 and proceeding East for 650 meters, shall be 50 km/hr.
- **THAT** 6. The maximum speed limit on Township Road 404A that runs from the Battle River North for 1200 meters to Range Road 154, shall be 60 km/hr.
- **THAT** 7. The maximum speed limit on Range Road 131 starting at Secondary Highway 608 proceeding North for 700 meters, shall be 60 km/hr.
- **THAT** 8. The maximum speed limit on Range Road 151 adjacent to the Village of Strome, starting at Highway 13 proceeding North for 700 meters, shall be 50 km/hr.
- THAT 9. The maximum speed limit on Range Road 103 from Secondary Highway 608 for a distance of 300 meters North and 300 meters South shall be 40 km/hr, and on Secondary Highway 608, from Range Road 103, for a distance of 300 meters East, shall be 30 km/hr.
- **THAT** 10. The maximum speed limit on Range Road 94A starting at Township Road 410 (the Coal Trail) which turns into Range Road 101 proceeding North to Highway 13, shall be 60 km/hr.
- **THAT** 11. The maximum speed limit on Township Road 420A from the corporate limits of the Village of Forestburg, and proceeding 350 meters West, shall be 60 km/hr.
- THAT 12. The maximum speed limit on that portion of Range Road 95A beginning Northwest from Secondary Highway 881 and continuing North and West for an approximate distance of 1165 metres to Range Road 100, shall be 50 km/hr.
- **THAT** 13. According to the provisions of the *Traffic Safety Act*, being Chapter T-6, R.S.A. 2000 and amendments thereto, the maximum speed limit on all remaining portions of rural roads shall be 80 km/hr.
- **THAT** 14. A record of the locations of the erected speed signs shall be kept at the County Office and shall be open to public inspection during normal business hours and shall be deemed part of this bylaw.
- **THAT** 15. No person shall drive at a greater rate of speed than the maximum rate designated by the signs erected along the highway.
- **THAT** 16. Any violation shall be dealt with according to the provisions in the *Traffic Safety Act*, being Chapter T-6, R.S.A. 2000 and amendments thereto.
- **THAT** 17. This Bylaw repeals Bylaw 03/12 dated the 23rd of May, 2012.
