Agricultural Inspector

Responsibilities:

- Inspection of Flagstaff County rights-of-way and private property for noxious and prohibited weeds.
- Maintain inspection records.
- Assist with grasshopper and clubroot surveys.
- Herbicide application with backpack sprayer and small handgun sprayer.
- General maintenance of vehicles and equipment.
- Maintain an organized, tidy and safe work environment.
- Follow all safety guidelines and wear appropriate Personal Protective Equipment (PPE).
- Responsible for ensuring compliance with Flagstaff County policies, the Healthy and Safety
- Program and the Human Resources guidelines and procedures.
- Assist with other duties and responsibilities that include shelterbelt, revegetation programs and additional assistance with maintenance of county lands as assigned from time to time by the Supervisor.

Qualifications:

- Able to operate basic computer equipment.
